## Record of decisions of the 10th meeting of the National Commission on Labour held on 31st July and 1st August, 1968 at Bombay

The 10th meeting of the National Commission on Labour was held in the Syndicate Room, Bombay University, Bombay from 3.00 P.M. to 6.00 P.M. on 31st July, 1968 and from 10.00 A.M. to 11.30 A.M. on 1st August, 1968.

Item No.1: Confirmation of record of decisions of the ninth meeting.

The record was confirmed.

Item No.2: Progress report of the work done in the Commission since its ninth meeting held at Bhopal on the 5th July, 1968.

The progress was noted.

Item No.3:(i) Revised Sections I and II of the Tentative Approach

(a) Chairman explained that the paper on Approach is not meant to bring out the recommendations of the Commission at this stage. Any suggestion in the paper which amounts to expression of views should be put in a non-committal manner. The Draft of the approach Paper as settled in the meeting is intended only to provide a broad guideline to the Secretariat for going ahead with its work.

(b) The Secretariat should bring out draft of the material to be incorporated in Chapters 1 to 5, Fart I of the Report. This will provide a background for the industrywise/subject-wise analysis of labour conditions which will follow in later parts. The approach now settled may need, if necessary, a revision in the light of the material to follow. In that sense today's decisions could be tentative but for the Secretariat's work in the coming weeks they are a guideline.

(c) The analysis of Directive Principles of State Policy in the Constitution should not be restricted to articles 39, 41, 42 and 43 as suggested. Other Directive Principles have also a bearing on the work of the Commission.

(d) The Approach Paper will be discussed in a general way without calling it an Approach Paper.

(e) Modifications made by the Drafting Committee in its meeting held on 3rd July, 1968, were accepted subject to further modifications listed below.

In 12th & 13th line of the para the clause 'the idea.... the Commission' should be deleted.

(xii) <u>Para 22</u>: It should be mentioned in this para that the various Labour Welfare Programmes need to be integrated first.

(miii) <u>Para 23</u>: The point regarding transfer of more money from Individual consumption to social consumption (collective consumption) should be brought out.

(xiv) <u>Para 26</u>:

The paragraph should be recast as 'In plantations, as a requirement of the Plantations Labour Act, 1951, there has been some progress in housing. The programme of housing labour in plantations as envisaged under the Act should have been completed within 12-15 years after Independence but this has not yet been done. There are even now many sub-standard houses in several Plantations. Reasons as to why better progress was not possible need to be examined.

A new paragraph to be numbered as 26A should be added before the present paragraph number 26A, giving an assessment of industrial housing. The present paragraph 26A should be numbered as 26B.

First sentence should be recast as 'In a few areas, housing provided by the management is alleged to be inaccessible to outsiders without the permission of the management'.

The following sentence should be added after the first sentence: 'Outsiders were not permitted entry into the plantation areas before the passing of the Plantations Act but this restriction has since been removed'.

(xvi) (<u>Para 28</u> (page 20)

Ninth line from below after houses, add 'and difficulties in getting reimbursements in Industrial Housing Scheme'.

(xvii) Para 31:

Page 22 ninth line from above: 'According to the 1958-59 enquiry' should be added before the 'Industrial worker' and the word 'Industrial' will have a small 'i'.

Following sentence should be added after completion of the above sentence:

"This, however, needs to be examined".

(xviii)Para 32

First two sentences should be replaced by the following sentence: 'On the whole it would be necessary to consider whether it is primarily the responsibility of the employeer, the State or the local bodies to provide housing or/whether it may be tackled by encouraging cooperative socie-ties or similar institutions in the respective areas/respective industries'.

Page 22 Line 5 from below 'be below' should be replaced by 'exceed'.

(xx) <u>Para 33</u>:

(xix)

At the beginning of the paragraph add 'Health'. In this paragraph mention should also be made about the effect of managerial efficiency and modern techniques of managements on productivity.

Reward for productivity is usually linked with basic wage and not with dearness allowance which constitutes an important part of the workers' emoluments. It should be examined whether this proves to be a disincentive in worker's effort at improving productivity.

In this paragraph mention should also be made about the wage structure.

Page 24 last line of paragraph 33 add 'satisfactory' before 'guide' in place of 'complete' as added by the Committee.

Before paragraph 34 another paragraph analysing the achievements in/the field of rationalisation should be added. (xxi) Para 34:

Page 24 - fifth line from the bottom the sentence beginning with 'This cannot' should begin with the words 'According to employers this cannot'.

At the end of paragraph 34 it should be mentioned that according to employers representatives automation is an extension of the process of rationalisation.

(xxii) <u>Para 34A</u>: This paragraph should begin with 'According to the labour representatives these .....'.

Page 25 third line from below 'saving' should be deleted.

Page 26 second line from the top, the sentence 'Selective approach ....answer' should be recast as 'Whether selective approach towards autmation will provide <u>/</u> o an answer is a point which needs to be examined'.

Last sentence of this paragraph 'Equally.. processes' should be deleted.

(xxiii)Para 35:

The concept of social security should be broken up into two heads viz., (a) Social Insurance and (b) Social Assistance.

The word pension should be added to gratuity wherever it appears in the paragraphs relating to social security.

Page 26 - eighth line from below after 'plantations' add 'in Assam'.

Forfeitures fund should also be mentioned in this paragraph.

L.I.C. should be asked to give the Commission a note on 'Idea of Integrated Social Insurance'.

(f) The Chairman reiterated that 'Approach Paper' is not intended to be suggestive of Commission's conclusions.

## Note on Perspective

(g) The Note on Perspective was then taken up for discussion. It was decided that this note should begin with the Directive Principles of State Policy given in the Constitution. Salient features of the Labour Policy Statements in the Five Year Plans and Tripartite Agreements should also be brought out. It should be analysed as to how far these have been implemented, so far. As for the Approach Paper, all modifications etc. made by the Drafting Committee in its meeting held on 3rd July, 1968 were accepted subject to further modifications as listed below.

(i) <u>Page 4</u>: Eighth line the word 'or insider'/after
 (para iv) 'outsider' by the Steering Committee should be deleted. Ninth line of word 'even' should be deleted. Last sentence of this para should be deleted. Reference to outsiders should either be deleted or be dealt with separately.

Mr. S.A. Dange was against the Commission's discussing the need for training of tradeunion workers. According to him this is an internal matter for members of the union.

(ii) <u>Page 5</u>: Last two sentences should be recast as para(xiii) "Whether more of collective bargaining and less of litigation in labour matters of the future' will change the situation is a matter which Commission will have to consider. The impact of inter-union rivalries on collective bargaining and voluntary arbitration will also have to be considered".

> Mr. S.A. Dange felt that the Commission should not discuss the question of union finances.

(iii) <u>Page 7</u> This paragraph should be recast; the word para(xiv) 'fashion' should be avoided.

Last sentence of this para should be deleted.

(iv) <u>Page 8</u> para(xvii) The first sentence of this para should be recast as 'In many cases, experience has shown that managements' as also the labours' attitude is inf huenced by various extraneous considerations.'

## (i) Conference on Labour Statistics.

The Conference was held at Simla on August 30 and 31, 1968, after its inauguration by the Chairman at New Delhi on August 28, 1968. The proceedings of the Conference ware circulated to the Members on September 23, 1968.

#### (ii) Conference on Agricultural Labour.

It is proposed to hold the Conference at New Delhi on December 23 to 25, 1968. A set of papers prepared for the Conference has been circulated to the Members on October 23, 1968.

#### 8. <u>Seminars</u>.

Shri Ram Centre for Industrial Relations, New Delhi organised its Fourth National Seminar on 'Labour Policy' in collaboration with the Commission at Varanasi from September 25 to 29, 1968. The Commission provided a grant of Rs. 8000/with the approval of the Government. Some Members of the Commission and about 60 experts participated in the seminar. Fourteen papers specially prepared for the seminar and the reports of some of the Study Groups set up by the Commission were discussed at the seminar under the following heads:-

- (i) Social Frame-work of Industrial Relations.
- (ii) Purpose and future direction of Labour Legislation.
- (iii) Wage policy and institutional frame work of wage determination.

The conclusions of the Seminar are being circulated to the Members.

In all 33 Committees/Study Groups/Working Groups have sent their reports of which 20 reports have been printed and circulated to all concerned. The Chairman has addressed the Chairman of the remaining Study Groups to send their reports early.

#### 10. <u>Resignation of a Mepber--</u> Shri S.A. Dange.

Shri S.A. Dange's letter of resignation of September 17, 1968, was considered by the Commission at its meeting held at New Delhi on October 4, 1968. The resolution (Annexure 'C') adopted by the Commission was sent by the Chairman to the Minister for Labour, Employment and Rehabilitation, suggesting, as was desired by the Commission, that Shri Dange's resignation might be accepted and the vacancy caused by his resignation need not be filled. The Government has accepted his regignation and a copy of the resolution issued by the Department of Labour and Employment on October 14, 1968, is appended (Annexure 'D').

#### 11. Budget.

The Government sanctioned budget grant of Rs. 13,77,600 against the estimates of Rs. 15,97,000 proposed by the Commission for 1968-69. The position was reviewed and revised sanction for Rs. 15,14,200 for 1968-69 has been asked for. This has been necessitated mainly due to setting up of larger number of Committees/Study Groups/Working Groups than those envisaged earlier, visit to most of the States during the current year and other unavoidable expenditure. A token provision of Rs. 2 lakhs has been proposed to the Government for the year 1969-70 as the Commission expects to finalise its report by the end of March, 1969. (The provision is mainly for pay and allowances for officers and staff for the month of March, 1968 which will be met from the budget for the year 1969-70 and other ad-hoc provision for meeting essential requirements.)

As was desired by some Members possibility of organising a visit to Andaman Islands in November has been examined. A visit to Andaman Islands upto November 10, 1968, is not practicable as there is only one weekly flight on Monday from Calcutta to Port Blair and return flight on Tuesday from Port Blair to Calcutta. It will give only half a day to Members at Port Blair. ## Progress Report of the work done in the Commission since its tenth meeting held at Bombay on July 31 and August 1, 1968.

The record of decisions of the tenth meeting of the Commission held on July 3<sup>1</sup> and August 1, 1968, as approved by the Chairman, were circulated to Members on September 6, 1968.

#### Visit to States Headquarters and other places.

The Commission completed its programme of visit to 15 States, Goa, Delhi Administration and Himachal Pradesh. The remaining State of Assam will be covered from October 16 to 18,1968. This will complete the recording of evidence in States and Union Territories.

## Meeting with MemBers of Parliament.

A set of special papers for discussions with Members of Parliament was prepared and circulated to the Members tolonging to Jan Sangh and P.S.P. groups who met the Commission at New Delhi on August 28, 1968. The Commission will meet the Members of Parliament belonging to other parties in November 1968.

#### Conference on Labour Statistics.

The Conference was held at Simla on August 30 and 31, 1968 after its inauguration by the Chairman at New Delhi on August 28, 1968.

During the Commission's visit to Simla some members paid a visit to Labour Bureau, Simla inspected the office and held discussions with the officers.

## Committees, Study Groups and Working Groups.

Since the Study Group on Newspaper Industry presented its report on July 5, 1968 as was reported to the Commission at its last meeting held on July 31 and August 1, 1968, the following Study Groups have sent in their reports:-

- (1) .Study Group on Banking Industry.
- (2) Study Group on Construction Industry.
- (3) Regional Working Group on Labour Administration (Northern Region).
- (4) Regional Working Group on Labour Administration (Southern Region).
- (5) Study Group on Sociological aspects of Labour-Management Relations.
- (6) Study Group on Air Transport Industry.

In all, 28 Committees/Study Groups/Working Groups have sent their reports, of which 13 reports have been printed and circulated to all concerned. The Chairman has addressed **P.O.** letters to the Chairmen of the remaining Committees and Study Groups to send their reports early.

The Study Group on Cement ran into trouble almost through out its existence. The Member Secretary met the Study Group in an attempt to persuade the members to see if they could get over the difficulties created by their immediate environments and give the Commission their expert advice on what had happened to the industry since Independence and project their thinking into the future. The Group came out with a report in which the first six chapters stated past experience and from then on there were violent differences of opinion. The trade union group and employers group prepared separate material. The former contained some insinuations against the 2nd Wage Board which insinuations the Employers considered as unfortunate. The report as signed by two trade union members reached the Commission. But even before we heard from employers, the Convenor of the Study Group published his own version in a local daily without consulting the Commission and his Colleagues on the Study Group. There was a protest sent to us by one employer member against this action of the Convenor. Since there was no further meeting ground, the Member Secretary informed the members of the Study Group that no useful purpose could be served by continuing its life and the Study Group was disbanded.

#### 6. Progress of work on the Technical side.

(1) Mechanical tabulation is nearing completion. Out of 672 replies received, 465 have been coded. 150 replies have not been found fit for being coded and the balance of 57 replies will be coded by the end of the month.

300 of the 465 coded replies have been posted and the balance will be posted by the 20th September.

- (2). Chapters I, II, III and V have been finalised. A note for the preparation of Chapter IV has been submitted. Draft of Chapter VI relating to agricultural labour has also been submitted. Two chapters on perspective and Indian economic situation also are in progress.
- (3) The Technical Wing has completed industry notes as follows:-
  - (a) Cotton Textile, (b) Heavy chemicals

  - (c) Road Transport ,(d) Air Transport, (e) Fertilizer, (f) Leather, (g) Oil distribution
  - and oil refining, (h) Manganese Mining,
  - (i) Contract Labour, (j) Port and Docks,
    (k) Rail Transport (l) Iron and Steel

  - (m) Coal Mines and (n) Stone quarries.

The Technical Wing also prepared five notes for discussion with Members of the Parliament. These include note on unorganised labour, trade union, wage policy, industrial relations and labour administration.

(4)The following industry notes are in progress:

> (a) Banking, (b) Jute, (c) Mica, (d) Cement, (e) Paper and Pulp (f) Coffee and (g) Forest and Fisheries.

- So far as manual tabulation is concerned, 672 replies (5)have been received so far. Unit I has completed manual tabulation of about 600 replies, Unit II, 462, Unit III, 310, Unit IV 300, Unit VI, 600 and Unit VII, 232. As a result of the decision taken to tabulate only important replies and to separate important replies from unimportant conc, the manual tabulation is likely to be completed by the end of the month.
- (6) Two volumes of statistics relating to manufacturing industries have been sent to the Press. The third volume is under preparation and is likely to go to Press by the 20th September. ( A note on the Scope of the Statistical Volume is attached.)

## A NOTE ON THE DATA COLLECTED DURING THE CENSUS OF INDIAN MANUFACTURE S AND ANNUAL SURVEY OF INDUSTRIES.

The National Commission on Labour has to study and report, <u>inter alia</u>, on "levels of workers! earnings, provisions relating to wages, the need for fixation of wages including a national minimum wage and means of increasing productivity including the provision of incentives to workers". To cover a part of the requirement under this head, the Commission has analysed the relevant statistics since Independence. An important source of such serial data is the Census of Indian Manufacturers (CMI)\* / and its successor the Annual Survey of Industries (ASI)7 published annually since 1946. The C.M.I for years 1946-1958 and the A.S.I. for 1959-1964. The Secretariat of the Commission has made an enalysis of the data and proposes to bring out Statistics of Selected Manufacturing Industries in three parts. Part I: Statistics of Selected Manufacturing Industries which will consist of the All India data for the period 1946 to 1964 as also data for the industries for which comparable time series are available for the same period. Part II: Data for the period 1946 to 1958 (the CMI period) and Part III: Statistics for some industries for which time series are available only from 1960 to 1964.

There are three tables for each industry in each State giving (a) Main characteristics, (b) Selected Indicators, and (c) Economic Ratios. In table (a) important data, such as (i) number of registered factories; (ii) coverage in the census/survey; (iii) capital employed (with break up); (iv) employment (with detailed break-up); (v) man-hours worked (with details); (vi) wages, salaries, benefits, etc. (with detailed break-up); (vi) inputs utilised (with breakup); (vii) gross out-put and (ix) value added by manufacture, have been presented. In table (b), index numbers on base 1946 = 100 or 1960 = 100, as the case may be, have been worked out for some of the characteristics presented in table (a). In table (c) some economic ratios, such as average employment per factory, capital employed per worker, man-hours worked per worker, inputs utilised per worker, gross out-put per worker, value added by manufacture per man-hour worked, out-put-capital ratio, out-put-input ratio, percentage of value added by manufacture to gross output and percentages of wages, salaries and benefits to value added by manufacture, are given.

The data presented in the "Statistics of Selected Manufacturing Industries" are subject to some limitations. During the CMI period, factories registered under the Factories Act, 1948 which employ 20 or more workers and using power were covered whereas the ASI covered only those factories employing 50 or more workers with the

\* CMI Data are proposed to be published at intervals of three years from 1946 to 1958. aid of power and 100 or more workers without power. This will introduce a constraint on comparability between years prior to and after 1958. The second limitation, common to both the CMI and ASI, is varying percentage of response over different years. Comparability over time is vitiated especially in those cases where the number of registered factories in a particular industry in a State is small. There have also been some differences in geographical coverage during the period of the CMI. Again, there have been some adjustments in the boundaries of States because of the Reorganisation of States. Another limitation to which these tables are subject, is that no adjustment has been made in the data for price changes over time. These limitations have to be kept in mind while drawing conclusions therefrom.

Table (a) contains the raw data from the CMI and the ASI. Bringing together these data for each industry by States since Independence itself will provide a link for evaluating the growth and work pattern of the industries. More important, however, are the derived data presented in table (b) on trends reflected by index numbers and in table (c) on economic ratios. The index numbers will indicate the direction of change in the matter of growth of the industries, employment, earnings, etc. on the basis of which more intensive studies can be undertaken to discover the underlying factors. The economic ratios will indicate the inter-relationship among some of the major factors of production and how such interrelationship has changed over time. For example, ratio of wages, salaries and benefits to value added by manufacture will indicate the share of employees in the net output of an industry. The ratio of capital to value of output is again an important economic indicator.

The Secretariat of the Commission is now engaged in preparation of notes on individual industries describing the position and prospects of the workers engaged therein. The health of the industry to a large extent depends on the conditions of the workers there. The data compiled in the "Statistics of Selected Manufacturing Industries" will, in a general way, portray the health of the industry and it will help the Commission to judge the condition of workers against that background.
