The following communique has been issued by the office of the Bihar Committee of the all India Trade Union Congress:

A meeting of the Bihar Executive Committee of the AITUC was held in Patna in its office on the 23rd and 24th May 1962.

The meeting was presided over by its permanent President Shri Habibur Rahman and was attended by representatives from important industrial centres like Jamshedbur, Jharia, Giridih, Bhurkunda, Kumardih, Dalmianagar and Barauni.

The Committee expressed its appreciation of the move of the Union Labour Minister Shri Gulzarilal Nanda and the Union Minister for Mines in organising a tripertite Conference for discussing ways and means for outting down Goondaism and terror raj in the coalfields. The decisions of this Conference will help the trade unions in the coalfields of Bihar to fight for elementary rights for the functioning of the TUs. The Committee urged upon the Govt. of Bihar to see that its police and magistrary in the coalfields take the decisions of this Conference seriously and change their methods so that the virtually lawless conditions perpetrated by the coal boses and contractors in the private collieries is brought to an end.

The Committee further resolved that a Campaign for speedy setting up of Coal Board for the coal industry be organised and the Wage Board should be required to submit its findings within six months. The Committee criticize the Govt. for not putting any AITUC representative on the Wage Board. The Committee was of the opinion that the ungrading of the wage rates in the coal industry could not be postpond, because the last tribunal gave rates which were very much lower than the norms of minimum wages decided by the I.L.C., that the production of coal as also the productivity of the miners has registered considerable increase during the last few years and the bigger effort that the miners is called upon to make for fulfilling the 3rd Plan target demands that the rates of the miners be increased. The Committee

called upon the miners' unions to organise an united campaign for formulating their demands and fighting for these before the Wage Board.

The Committee expressed its serious dissatisfaction with the manner in which the cement companies were implementing the recommendations of the cement Wage Board. Thus, in Dalmianagar the workers were denied the full benefits on the intorable plea of phasing, and in almost every cement factory there was dissatisfaction over the wrong categorisation and grades of the workers. The committee called upon the unions concerned to draw a memorandum on this question and demand the setting up of a tripartite for settling this problem.

The Committee further resolved that those workers of Dalmienager industrial complex, who ere not benefited by the Cement and Sugar wage Boards, should also have sliding scae of d.a. and that pending the adoption of this principle, their d.a. should be increased by Rs. 12/- per month. It also supported their demand for four months mobus from the last two years.

The Committee welcomed the decision of a number of TUs in the Fire

Bricks industry which employes about 16,000 workers, to organise a conven
tion of all TUs in this industry in order to campaign for a tribunal for up
grading of wages and d.a., bonus and decentralisation of labour.

The Committee severely criticised the Govt. of Bihar for their niggardliness in meeting the just demands of the secondary school teachers and on non-gazetted Govt. employees of the State. The few crump thrown by the Govt. to the employees wearing Hungry badges and the impoverished meek teachers have failed to satisfy them. The Committee called upon all the TUs to come out in their support actively.

By a resolution the Govt. of Bihar was requested to release the longterm political prisoners in the State many of whom are old trade union leaders. In this connection it underlined the cases of workers convicted in and the Gua Murder case,/Dharmabandh Murder case. It decided to take a deputation to the Chief Minister, Govt. of Bihar for this purpose.

The Executive Committee expressed its severe condemnation of the recent neuclear tests by the U.S. Govt. and urged the workers to intensify the campaign for banning all tests and for progressive disarmament. The Committee expressed grave concern over the despatch of U.S. Maniners to Thailand and the interfreence of the U.S. Govt. in Laos and warned the U.S. Govt. to get out of that area.

In the end the Committee decided that the next Conference of the Bihar State Committee of the AITUC be held at BARAUNI in November 1962.



### NOTE REGARDING BARAUNI OIL REFINERY

The construction work is governed by the Minimum Wages Act. The Bihar Rules under this Act, provides for a weekly day of rest with pay. But neither the Indian Refineries Ltd., nor the contractors under it are paying any wage for the weekly day of rest. Other industries, e.g. Mica, which are governed by the same Act, pay for the weekly day of rest.

These workers have not been paid arrear overtime rates for the period ending 16th May 1962. Overtime rate under Bihar Rules is only  $l_2^1$  times the normal. And even at this extraordinary low rate the arrear over time has not been paid. For awork on weekly day of rest, i.e. Sunday no overtime rate is paid by I.R.L. They force the workers to take the weekly rest on some other day for the week concerned.

A number of skilled workers were transferred from Refinery at Gauhati to Barauni. They were served with orders of IRL authorities at Gauhati to join Barauni. But none of these workmen have got their services continued, nor were they paid any retrenchment benefit at the time of leaving Gauhati on the ground that it was not a retrenchment but a transfer. Some of the workmen so transferred have got their rates reduced also. I am asking the Barauni union to send names of the workmen concerned to you, but meanwhile you can discuss the matter on the plane of principle.
