The Photo must be signed and stamped in such a way that Doctor's signature & stamp appears partly on the photo and partly on the certificate.

2. In the case of temporary disability, the certificate will be remain valid for (1) five years of issue. In the case of person in the age group 25-35 years. In the case persons above the age 35 years &

3. Ten years in case of person in the age group of 25-35 years. In the case persons above the age 35 years certificate will remain valid for who a life of concerned person. After expiry of period of validity of concessional ticket and during the journey, if demanded.

4. No alteration in the form is permitted.
