For identical reasons, there is also no scope under 33(c) but an attempt fan be made under 33(c)(2). The course open is, of course, is to raise a dispute and pursue it. The State Implementation & Evaluation Committee may also be moved to intervene in the matter of non-implementation of the interim relief recommendation.
