The humble representation of Yerramala Potrayya, Harijan on behalf of 60 Harijan Families of Ayyavari Polavaram, Polavaram, Polavaram Taluk, West Godavari District, Andhra Pradesh, most respectfully submits as follows:

Respected Madam,

Sub:-Request for taking appropriate prompt action against the concerned from dispossessing the 60 families of Harijans from R.S.No.184 measuring 30.00 of Ayyavari Polavaram, Polavaram Taluk, W.G.D., (A.P.)--Chinna Cheruvu an abandoned tank which is in the possession and enjoyment of the above 60 Harijan families from the last 50 years -- regarding.

We have seen the directions given by the central government recently to the state governments directing that necessary arrangements or orders have to be made to remove all impediments or obstructions that may be caused to Harijans with regard to the lands either owned by or allotted to the Harijans and that necessary action be taken for their uninterrupted cultivation and possession etc. In view of the above directions we request that your honour has to examine the following case and direct the state government to take immediate, proper and prompt action in the matter.

1. We are all belong to 60 Harijan families. ex.zamindar granted rough pattas for an extent of 30 acres in R.S.No.184 which is an abandoned tank poramboke even then of Ayyavari Polavaram, Polavaram Taluk of West Godavari District, (A.P.), which is known as 'Chinna Tank' to our 60 Harijan families. We have paid the requisite cists upto the year of Zamindari Abolition, for which we got receipts with us.

2. After taking over of the village by the state Government as per the Zamindari Abolition Act we are continued in possession and enjoyment and we paid cists to the Government regularly upto the end of 1979, which receipts also we got with us. All our families are pulling on by cultivation of the said 30 acres of land since 1952.

3. As the matter stood thus, some selfish land-lords with an evil idea of dispossessing us from the said land managed the Godavari special division (irrigation and development) department to cause repairs to the above said Chikka (Korova, an abandoned tank porastoko which was long ago cancelled by the then zamindar and which is under our cultivation, whereby the said 30 acres will be inundate in waters. They got prepared an estimate for the said repairs to the tune of Rs. 2,40,000/- which is beneficial to the engineers concerned as well as to the contractors at great length. If the said repairs are carried out to an abandoned tank, will dispossess us and deprive our livelihood. This is the main motive of the said selfish land-lords, who managed to prepare the said estimate.

4. The joint collector has not perused our records. The Collector, West Godavari district, basing on the notes of the joint collector passed orders, vacating the stay granted to us, to carry out the repairs to the said Chikka Tank.

5. Against the order of the collector, we have put in a representation to the Chief Minister, irrigation minister and to the Revenue minister of Andhra Pradesh and also gave a telegram to stop execution of the proposed repairs to the said abandoned tank which is under our regular, continuous cultivation by appointing a -

Legislative committee and enquire into the matter by Chief Engineer (Irrigation) fore the said - Committee whether the repairs necessary or not to the said abandoned China Canal. But upto now none of them have not taken any action on the said representations.

5. When junior engineer and assistant engineer came to the said tank on 4-4-1980 to carry out the repairs to it, we have commenced peaceful satyagraha at the said tank from 4-4-1980. This is for your information.

So, we humbly pray your honour to kindly take necessary and prompt enquiry into the matter and direct the state government to stay the execution of repairs to the said China tank (an abandoned tank) and save all these 60 Harijan poor families from starvation and do justice to these poor and helpless Harijans.
