

The fourth meeting of State Implementation & Evaluation Committee was held on 25th inst.

Since our Representative on the Committee Shri B. S. Dhume has been out of Country Bome time past, we had nominated Shri G. Sundaram, a member of our Executive, to represent us at the meeting.

On the day previous to themseting Shri Durve, Secy., State I. & E. Committee, informed our Office that our Shri G. Sundaram, would not be allowed to substitute for Shri Dhume.

We asked for a written reply to our letter nominating Shri Sundaram, but that was never done.

The matter was raised with you. It was pointed out to you that it had been the practice of the Committee to allow substitutes. We pointed out that in the very first meeting of the Committee Shri Prabhu Mehta, a representative of the All India Machinery Manufacturers' Organisation on the Committee who could not attend, was allowed to be substituted by one Shri K. Naoroji.

In spite of this, however, Shri Sunderam was not allowed to attend the meeting.

This approach adopted by you towards our Organisation is therefore, we must say, discriminatory. We record our protest against this discrimination.-



An urgent meeting of the Executive of the MRTUC was held yesterda to consider the implementation of the resolution of the General Council of the AlTUC in the State, and the situation arising out of indiscriminate arrests of trade union leaders and functionaries in the State.

A copy of the decisions of the Executive is being sent to you separately.

Out of the 39 members on the Executive, 15 have been arrested so far under the P.D.Act.

Of these several are AITUC's and MRTUC's nominees on different Tripartite Bodies. The Executive considered this situation and decided to substitute its nominees on two of the State Bodies. The new nominees are Coms. G. Sunderam on the State Labour Advisory Board and Com. S.G. Patkar on the State Evaluation and Implementation Committee.
