I, Amarnath Sharma, General Secretary, Garment and Allied Workers' Union, hereby state that there is wide scale Minimum Wages violation going on in the Garment Sector Establishments in Gurgaon and Manesar. I, as per the information received from your office, some of the biggest violators of the Garment Industry working in Gurgaon- Manesar have never been inspected in the last two years under the provisions of the Minimum Wages Act. It is my humble request to conduct a thorough inspection and investigation of Minimum Wages Violation by the following Establishments/ Companies.
