#### NOTIFICATION

No.G.S.R...... In exercise of the powers conferred by section 38 of the Industrial Disputes Act, 1947 (14 of 1947), the Central Government hereby makes the following further amendments to the Industrial Disputes (Central) Rules, 1957, the same having been previously published as required by subsection (1) of the said section, namely:-

- 1. These rules may be called the Industrial Disputes (Central) Amendment Rules, 1961.
- 2. In the Industrial Disputes (Central) Rules, 1957, hereinafter referred to as the said Rrules, for rule 10A, the following rule shall be substituted, namely:-

"10A. Parties to submit statements. The employer or the party representing workmen involved in an industrial dispute shall forward a statement setting forth the specific matters in dispute to the Conciliation Officer (Central) concerned whenever his intervention in the dispute is required."

In rule 10B of the said rules,

(1) for sub-rule (1), the following sub-rule shall be substituted, namely:"(1) Where the Central Government refers any industrial dispute for adjudication to a Labour Court, Tribunal or National Tribunal, within two weeks of the date of receipt of the order of reference, the party representing workmen and the employer involved in the dispute shall file with the Labour Court, Tribunal or National Tribunal, as the case may be, a statement of the demands relating only to the issues as are included in the order of reference and shall also forward a copy of such statement to each one of the opposite parties involved in the said dispute:

Provided that where the Labour Court, Tribunal or National Tribunal, as the case may be, considers it necessary, it may extend the time limit for filing of such statement.";

(ii) in sub-rule (2), in the second proviso for the words "filing of rejoinder by any party" the words "filing of such rejoinder" shall be substituted.
