Resolution No. 3 passed in the General body Meeting held on $12 / 8 / 58$
arrest the increase in yam price - supply of yarn on reasonable price relax fupcrt restriction of artificial silk yarn and dyeing materials.

This meeting views with grave concern over the recent abnormal increase in pile of yarn. ibis causes the chain reaction of increased price in cloth, decrease trend of rages, of stock due to lower. purchasing power of the people and invitably lewis to a crisis in the very industry. Further this reefing feels $t$ that the Import restriction on artificial silk yarn and dyefig materials gave fresh fillip to the shooting up of the prices.

Therefore this meeting request the Government, of India and the Government of Madras to take urgent measures in forcing dow the price of furn, supplying yarn on reasonable price and relaxing import restriction on orificial silk, dyeing nom materwils and dyeing xeterofals.

Resolution:No.4. Compulsory purchase of Handioom Clotin below cost price Prom Primary Cooperative Heavers' Societies - Subsidies from Cess Fund to meet out the loss - request of.

In the name of clearing off the in fiandloors
stock, the Government of Madras restored compulsory purchase of handlocif cloth below cost price. Conseñesntiy the primary Weavers Cooperative societies in general and the Tirucmi Weavers societies in particular were hard hit and thereby incurring a loss of $\mathrm{Fi} 2 / \mathrm{c}$ per sere. This meeting feels that this is the great injustice to the poor weavers and therefore request the Government of babas to Le pleased to consider the plight of poor societies and sanction subsidies to meet the loss out of Cess Fund and thereby relieve the distress of the poor weavers and their societies.
