

Dear comrade Dange.

With refference to our letter No 489 of December 29,1965 we beg you once more, this time on behalf of the Board of our TUI, for your cooperation to be communicated to us as soon as possible the name of the comrade of one of the trade unions, affiliated to our TUI, to take up the place in the Administrative Committee of the TUI, which was determined for India by the IV International Conference, which was held in September 1965 in Prague.

According to the decision of our Board, which met in February of this year in Paris, the regular session of the Administrative Committee of our TUI will be held in Budapest on the 17th of May

of this year.

The Board expressed its unrest from the fact, that up to this moment no representative of India has been nominated to occupy

the place in the Administrative Committee,

This circumstance urges us to insist before you for a reply. We have to acknowledge before you, that the more the reply is being delayed, the more the difficulties in connection with the organisation of the Session are growing.

But we are troubled most from the guestion as to whether India will be represented in our Administrative Committee and concretely in this case-whether it will be represented in the forthcoming session of the Administrative Committee.

In expectance of your early reply, we beg you, comrade Dange, to accept the fraternal greetings of our Secretariat and wishes for success.
