Dear Comrade,

Our Unions in A.G.F. have raised a denend with the Aime hanagement in respect of Dearness Allowance. At present the Dearness allowance is linked to the cost of living index and the rate is 0-2-3 per point of rise above 100. We have demanded C-4-0 instead of 0-2-3. We have also demanded that D/A should be merged with the wages. At present only for purposes of Provident Fund contributions 50% of the D/A is taken as part of wages. For other terminal or other benefits no part of D/A is treated as part of wages. Negotiations with the Mine Management took place on 23-3-1961, and further talks are to be held on 5-4-1961. In the meanwhile the Management want us to furnish our arguments in support of the demand. What is the case for a revising the rate of D/A from 0-2-3 per point to C-4-0? The present agreement in respect of the D/A was entered into in 1950, why do we say that now only C-4-0 per point will neutralise the rise in prices?

Are there any industries, where D/A is merged with wages. Cnly in respect of Government employees such a merger is recommended. The same principle is not extended to Govern ent industries, and Govt. employees did not have D/A linked to cost of living, only a flat rate D/A was being paid.

we want on the above two points as much information as is possible to help us in our negotiations on 5-4-1961. Please help us with as much information as is available with you and also with general guidance.

The Mysore Mine Workers' Union, Marikuppan, K.G.F. representing the workmen

And

The Superintendent, KGMU (Mysore Mine) Margikuppam, representing the Management.

A dispute in the matter of the application and interpretation of the Standing Order pertaining to the Aolar Gold Mining Undertakings (Mysore Mine), Marikuppam has arisen between our Union representing the workmen and the Management of the Kolar Gold Mining Undertakings (Mysore mine), Marikuppam, K.G.F. The attempts made by the Union to have the dispute settled by negotiation and consiliation having ended in failure, the Union on behalf of the workmen and as the aggrieved Party in the dispute is submitting the dispute to this Honourable Court under section 15 A. of the Industrial Employment (Standing Orders) Act 1946. The details of the question to be determined and decided are as under:

1) On 20-1-1960, the Asst. Superintendent of the Mine suspended two Underground workmen by name Gopal, T.No.1561, and Ettiyan, T.No.2106, for 30 working days under Standing Orders (15) (4) (m). Standing order 15 (4) (m) reads as follows:

15. (1) Any workman may after due enquiry be fined, suspended, reduced in grade or pay or transferred to other work by the Officer under whom he works for any of the under under mentioned offences. The offences if repeated or in any gross case may be treated as misconduct under Standing Order 14.

- (4) Inter alia any of the following acts or omissions will be treated as an offence under this Order.
- (m) Quarrelling, fighting and assault within the Employer's premises.

2) The charge against the workmen as per notice dated 30-12-1960 served on them was that on 21-12-60, they "along with some others assaulted I.Thankaraj, Clerk U/G Time Office while he was on his way to work."

3) The alleged incident took place on a road which also leads to the employers premises. The Management of the Mine have interpreted the terms "within the employer's premises" occuring in S.O. 15(4)(m) to include the road leading to the employer's premises and on the basis of such an interpretation they have applied the Standing Orders against the two workmen and have punished them as stated in 1) above.

4) The Union hold that the interpretation given by the Management as stated above is wrong and that "within the premises" cannot include a road leading to the premises. The particular road in question where the alleged assault took place though is situated on the property of the employer, is a thorough fare, the entry to which is neither controlled nor regulated. The road is also not exclusively meant as a road to the employer's premises, it branches out to join other roads and connect other places, while it is true that one of its branch also leads to the employer's premises.

5) The Management of the Mine have given a Balse and untenable interpretation to the Standing Orders with a view to enable them apply the Standing Orders against the workmen and have them punished. These workmen are active members of the Union. The alleged victim of the assault Sri 1. Thankaraj is an active worker of the N.C.O. Central Union which is not a representative Union and to which the Management of the Mine have accorded recognition against the letter and spirit of the Code of Discipline to which the Management are parties. This N.C.O. Central Union and the victim of the alleged assault Sri 1. Thankaraj are backed by the Management of the Mine against the interests of the vast majority of the workmen.

5) The Union also beg to state that the enquiry was not conducted fairly and justly, the accused workmen were not given full opportunity to cross examine the complainant and the witnesses brought on his behalf, they were also not granted opportunities to produce witnesses in support of their version of the case.

7) The Union therefore prays that this Honourable Court may be pleased to give decision as to the applicability and interpretation of the said Standing Orders 15(4)(m) pertaining to the Kolar Gold Mining Undertakings, (Mysore Mine).

OBJECTION STATEMENT FILED BY THE OPPOSITE PARTY.

1. The Mining Undertaking called the Kolar Gold Mining Undertakings belongs to the State of Mysore and is carried on by it. The Mysore Mine is a part of the Kolar Gold Mining Undertakings. The Managing Director, Kolar Gold Mining Undertakings is the person duly authorised by the State to represent it in relation to the Kolar Gold Mining Undertakings before Courts and Tribunals.

2. It is true that two employees of the Mysore Mine by name Sri Gopal, T.No.1561 and Yettian, T.No.2106 were suspended by the Assistant Superintendent of that Mine for misconduct under Standing Order 15(4)(m) after due enquiry. The said two employees assaulted another employee of the Mine by name Sri I. Thangaraj while the latter was going to his work. The assault took place on a road belonging to the Kolar Gold Mining Undertakings. It is admitted by the Applicant in paragraph 4 of the petition that the road on which the assault took place is situated on the property of the employer. There are a number of inter linking roads in the mining area belonging to the Kolar Gold Mining Undertakings and all these roads belong to and are maintained by the Kolar Gold Mining

Undertakings. They form part of the employer's premises. It is quite clear that the place where the assault took place is the employer's premises. It is, therefore, submitted that there is no difficulty in interpreting the expression the employer's premises used in Standing Order 15(4)(m).

3. The averments in paragraphs 5 and 6 of the application are irrelevant and the Opposite Party repudiates the allegations made against it in the said paragraphs. The Opposite Party is not siding or backing any union or employee as against the applicant. The enquiry against Sriyuths Gopal and Yettian has been conducted according to law and every opportunity was given to them to defend themselves.

4. The Applicant raised an industrial dispute regarding this matter and conciliation proceedings were held by the Conciliation Officer (Central), Madras. On receipt of the report of the Conciliation Officer, the Government of India, Mininstry of Labour and Employment have informed the parties that as the two employees were punished after observance of due procedures, the Government of India do not consider the dispute fit for reference to an Industrial Tribunal for adjudication. A copy of the said communication is submitted herewith. The application filed by the Applicant is therefore vexations and not maintainable.

5. The other allegations in the application not specifically traversed in this Objection Statement are not admitted.

The application is therefore liable to be dismissed with costs of the Opposite Party.

REPLY STATEMENT OF THE APPLICANT.

The applicant begs to state the following in reply to the objection statement filed by the Opposite Party. 1. The averments in the application are hereby reaffirmed and the allegations and confections in the objection statement of the opposite party contrary to or inconsistant to what is stated in the application are hereby denied.

2. The contention that the road on which the alleged assault took place belongs to the Kolar Gold Mining Undertakings is incorrect and misleading. That, not withstanding the fact that the Undertakings may have the responsibility in maintaining the road in question, it is a public road to which the general public have an unrestricted right to use and it is being used as a public road by the general public ever since the begining of the Mining operations. As such the road is not the exclusive property of the Undertakings, much less does it constitute the premises of the employer for the purpose of S.O. 15 (4) (m) and the mere fact that one passing along the road in question could also reach the employer's premises could not constitute \mathcal{N} "the employer's premises" within the meaning of S.O. 15 (4) (m).

3. Further the circumstance that the alleged victim of the assault was an employee of the Undertakings, is irrelevant for the purpose of determining the propriety of holding the alleged assailants liable to be punished under S.O. 15(4)(m) which referes to an assault within the employer's premises. It may be of interest to note that even according to the allegations of the victim to the alleged assault, the assailants included some 3 or 4 other men who are not employees of the opposite party.

The further contention that the workmen are liable 4. to be penalised under the Standing orders by reason of the alleged assault taking place on a road situate on the property of the employer, is untenable, and unfair, and would lead to very grave absurdities if it is logically extended. That the reading of the Standing Orders and the meaning of the phrases "employer's premises" or "employer's property" in the various relevant clauses of the Standing Orders, would lead one irresistably to the conclusion that the employer's premises as used in the Standing orders is restricted to the actual workplace, or the precincts of the Mine with in which the entry of persons or their conduct is actually and legitimately controlled or regulated or could be controlled or regulated by the Mine Management or their The use of the phrase "employer's premises" in the agents.

sense above indicated would harmonise the clause in question with the object of the Standing order and prevent its abuse beyond the scope of maintaining discipline among workmen in relation to the work on which he is employer.

5. It is submitted that the employer's power to take punitive action against the employee under the Standing Order in question cannot be extended for acts done outside the work place or outside the precincts of the employer in his actual or exclusive control, and it cannot obviously extend to any alleged misbehaviour like quarrelling, fighting or assault outside the premises as stated above as it would be putting the employer in the place of the State entrusted with the obligation to punish wrong doers where ever the wrongful act is done. It is also admitted on facts that the alleged assault is absolutely unrelated to the work or work place.

6. It is submitted that the interpretation put by the employer viz. employer's premises within the meaning of S.O. 15 (4)(m) includes a road leading to the premises is opposed to the plain meaning of the term in its ordinary connotation and is opposed to the reasonable and just meaning that could be given to the phrase "employer's premises" so as to keep the scope of the S.O. within its legitimate objectives.

7. The applicant prays that this Hon. Court may be pleased to give its interpretation of the meaning of S.O. 15(4)(m) in relation to the controvery as stated in the application and allow the application with costs.

FINDINGS:

Written complaint was received from Sri 1. Thangaraj, Clerk, in U.G.F Time Office, to the fact that he was assaulted by two underground workers namely Gopaul, T.No.1561 and Yettian, T.Bo.2106, along with four other workmen on 21-12-60, at about 6.20 a.m. near Mr. Sathyabodha Rao's bungalow compound corner in the mining road, while he was coming to work.

4)

A preliminary enquiry was conducted on 27-12-60 when statements of Sri Thangaraj, Yettian and Gopaul were recorded. Charge sheet was issued to Yettian and Gopaul under S.O. 15 (4) (m) for assault and someoned for enquiry on 2.1.1961.

On 2.1.1961 when the **q** enquiry started the said accused Yettian and Gopaul informed me that they are not submitting themselves for any departmental enquiry as a Police case was pending against them. Despite my advice they walked away while the statements of Thangaraj was being recorded.

The enquiry was continued and the statements of Thangaraj and Kothandapani were recorded on 2.1.61 and 6.1.61 and the same posted to be continued again on 9.1.61. On 9.1.61 the said Gopaul and Yettian informed me they are willing to be present for the enquiry and appeared for he enquiry duly when the statements of Thangaraj and Kothandapani were read out to them and they were given opportunity to cross examine them.

Gopaul and Yettian were told that the enquiry will resume again on 10.1.61 at 3 p.m. But they informed me that they want to go on leave. I advised them that leave cannot be granted and to be present for enquiry on 10.1.61. The same was once again conveyed to them on 10th morning also. But they did not attend the enquiry as directed. The witnesses of Thangaraj viz. Sam Iruchan, C.Lawford and A.Monzsay were examined and their statements recorded thereon. On 11th Gopaul and Yettian were sent for, but they did not present before me. Yettian absented himself without permission. On 13th morning I sent for Gopaul and advised him to be present for the enquiry on Monday, the 16th at 3 p.m. But he did not respond, even though he said he will come.

The statements of Thangaraj and his witnesses and the statements of Yettian and Gopaul recorded during the preliminary enquiry were carefully studied by me and also on the basis of the evidences I heard during the enquiry, I have come to the following conclusions:-

1. That it is a fact that Thangaraj has been assaulted on the morning of 21.12.60 at about 6.20 a.m. while he was on his way to work, on the road to Edgar's near the corner of the Chief Engineer's bungalow compound.

2. The part played by Gopaul in the assault is clear as in his own statement recorded during the preliminary enquiry he has stated that he had a fight with Thangaraj and they hit each other. The same was stated by Gopaul during his cross examination of Thangaraj and Kothandapani.

3. Gopaul stated that he assaulted Thangaraj because Thangaraj provoked him and assaulted him first. But his alleged provocation and hit by Thangaraj is neither substantiated nor proved in the enquiry.

4. In the case of Yettian the evidence of Thangaraj is correborated by Kothandapani. In Monasayos evidence also he states he saw both of them running away. This could be taken as corroborating circumstantial evidence.

5. It is evident that the whole incident is premediated by a group of workmen and hence the plea of provocation cannot be substained.

6. Even though all opportunity has been given to the said accused Gopaul and Yettian to be present for the enquiry and to produce their witnesses if any, they have not responded to it.

7. It is conclusive proof from the Medical certificate that Thangaraj was assaulted on the morning of 21.12.60 and even in his first report he has mentioned the names of Gopaul and Yettian as the persons who has assaulted him. There is no reason why he should give names of persons other than those who actually assaulted him.

8. As the said accused Gopaul and Yettian have been personally warned by me to appear for enquiry from time to time and they have been deliberately evading the enquiry, and as sufficient opportunity have been given to them to defend themselves, it is not possible to postpone the enquiry indefinitely and hence I close the enquiry.

To sum up the case it has been proved beyong doubt that Thangaraj, Clerk, Edgar's Time Office, has been assaulted on 21-12-60 at 6.20 a.m. by Gopaul, Yettian and some other workmen who could not be identified and 1 find Gopaul, T.No.1561, and Yettian, T.No.2106 guilty of the offence charged with under S.O. 15(4)(m). I hereby order that they be suspended from work for a period of 30 working days with effect from 2.1.1961.

In awarding the above punishments I have taken into account the gravity of the misconduct and the previous record of the workmen concerned.

Statement of I. Thangaraj.

On 21.12.60 while I was coming to office (at this stage of enquiry Gopaul and Yettian informed the Asst. Superintendent that they are not prepared to be present inspite of the advise of the Asst. Superintendent who outlined the procedure to be adopted at enquiries and walked away) V.K.S.

Statement of Thangaraj continued: Along with Mr.Kothandapani pushing our cycles on the mining road leading to Edgar's South Gate. Just above Mr. Sathyabodah Eao's bungalow corner we were just overtaking Foreman Sam lruchan who was also proceeding towards Edgar's Shaft all of a sudden I received a blow on my back with a carbide lamp. Immediately I turned around I saw it was Gopaul who hit me. Again I received another blow by Yettian with his carbide lamp and two others who were with them his me simultaneously with their Carbide lamps, two more men were there and they were directing them. All the above were our mining workers. Out of the six who crowded me and assaulted me 1 can identify and name two workers. They were Gopaul and Yettian. The others four I can identify if I see them again. All the above four men kept on beating me with their lamps till I fell down and continued to hit me for a little while even after falling down by which time I received wounds on my left hand and on my face and a number of contused wounds all over my body. I kept on shouting for help as I could not defend myself and immediately they ranaway. Till then nobody came to my help. I was bleeding through my mother and the blood stains could have been seen by the passersby. After a few seconds when I got up I saw my clothes too stained with blood. At the same time I was able to See Mr. Boesinger coming towards me talking something with C. Lawford. And also I saw Sri Manasay, attender, Agents Office coming towards me. Mr. Boesinger asked me as to what happened. As I was narrating the incident he took me to the Ambulance room at Edgar's. I was sent to the K.G.F. Hospital, where I was given First Aid and from where I was sent to Govt. Civil Hospital, Robertsonpet, for treatment. I lost my watch during the incident which was later shown to me in the Police Station.

Cross Examination: Re-examination:

- Q. You say that you identify these two workers Gopaul and Yettian, Do you know these people before - if so how?
- A. I was once before assaulted on 2.1.'59, inside the Edgar's Yard. I saw this man Gopaul was the person who assaulted me. At that time I didn't know his name, nor aware where he was working. So I could not make any complaint then. But after some time I happened to see him often near the Time Office when I made enquiries and found out his name. I have also seen him at Managing Director's Office on 20th of December 1960. I knew Yettian for some time when he used to come to the Time Office.

- Q. Do you have any witnesses to produce on your behalf? If so who are they?
- A. Yes. Kothandapani of Time Office, Manasay, U.G. Agents Time Office, Sam Iruchan, U.G. Foreman, Mr.Boesinger and Mr. Lawford.

On 21-12-1960, at about 6.20 a.m. I was proceeding to my office. I met Sri I. Thangaraj near Cresswells Shop on the road leading to Edgar's "haft. We both got down from our cycles and started walking up the mining road towards Edgar's Shaft, pushing our cycles. We reached near Sathgabodha Rao's compound corner. I sew a group of workers surround Sri I. Thangaraj. They started beating Sri Thangaraj. I was little behind Thangaraj. At that time foreman Sam Iruchan was also there. There were about six workmen involved in this assault of Thangaraj. I can identify two of them. They are Gopaul and Yettian. Thangaraj fell down. He shouted and the workers ran away. A Joint meeting of the Executive Committees of the Trade Unions in Kolar Gold Fields affiliated to the All India Trade Union Congress and the Karnatak Provincial Trade Union Congress (The Mysore Mine Workers' Union, The Champion Reef Mine Labour Association, The K.G.F. Hospital Workers' Union, The K.G.F. Dairy Workers' Union and The K.G.F. Sanitary Board Workers' Union) and an associate union the K.G.F. Electricity Department Labour Association were held on 22.8.'61 at Marikuppam Sri. K.S.Vasan presiding.

The following decisions were made:

1). To run a campaign of door to door Collection of materials (food grains and clothes) and contribute the Collections to the Chief Minister's Flood Relief Fund.

2). To organise and take out a procession demonstration the 28th inst. to i) protest against the Callons and indifferent attitude of the K.G.F. Sanitary Board and the Government re. the present acute water shortage position in K.G.F. and to demand immediate remedial measures ii) protest against the proposed Prohibition Bill and its most Obnoxions, anti-democratic provisions and to demand that the same be dropped.

3). To launch a hungerstrike from 4th September 1961 in response to a state-wide call for such protest action by the Karnatak Provincial Trade Union Congress to protest against the anti-working class Labour policy of the Government of the State and to urge its revision and to protest against the attitude of the Mine Management towards the issue of revision of Dearness Allowance rates to K.G.F. workmen and to demand fruitful negotiations to reach an amicable settlement of the issue. It is resolved that Sri. Sri. S.A. Dange, M.P. General Secretary of the All India Trade Union Congress addressed the gathering. Sri. Dange exhorted the workers to gight Communalism and Casteism and to unite in defence of their rights and interests and to win better conditions of work and life. He dealt at bugth on the working of the Public sicker industries and criticised the way in which they are run with particular reference to the treatment of the workers therein, their work conditions and demands. 8) Demanding Land reforms.

9) Demanding revision of Dearness Allowance Scheme to compensate adequately the abnormal rise in cost of living and regarding various local issues including wages grades. Sri. S.S. Mirajkar, President of A I T U C. address the delegates and other activists of the T.U. movement. He exhorted the workers to close their remarks up against communalism and Casteism, disruption and to resist all attacks on their rights and interests. He called on the Government to run the industry in the best interests of the Nation and the workers employed in the industry.
