Dear Sir - Dear Sir,

I bring to your notice the atrocities committed by the police on the inhabitants of Shahidnagar, Ghaziabad in U.P., and the ransacking of the local office of the Communist Party of India (C.P.I.) and the arrest and beating of the party workers on 1.3.1980. Having informed of these incidents I along with Shri Kalishankar Shukla, a member of the Central Executive Committee of our party and former secretary U.P. State unit of the party visited Shahidnagar on 2.3.1980.

We first went to the local party office and found the office ransacked, records and papers burnt and blood stains on some wooden pieces and on the floor and a blood stained cap. The attack took place after 5 p.m. on 1.3.1980. At that time the Secretary of the local party branch Rahmat Ali and few other party workers were in office. A sixty year old carpenter Manva Maistry was doing some carpentry work for the office. All of them were beaten and forcibly taken to the police station.

We visited a number of houses which were broken open by the police and the household things thrown everywhere. We met a number of men, women and children with marks of lathi blows and other injuries. We also visited the local mosque from where some people were dragged and taken into custody.

I do not wish to narrate all the instances of beating up of individuals. It will require more space. However I wish to cite a few instances to show how innocent people including women were beaten. The sixty year old woman Rafikan was ill with fever and was lying on

lying on a coat when the police entered her house. She had marks of several lathi blows on both her hands, left leg and on her back. She said she was hit by the rifle butt also. She was wreathing in pain when we met her and unable to move from the coat on which she was lying. Her 18 year old younger son Sundu was lying semiconscious with swellings caused by beatings. He had a wound on his head. Her elder son was also beaten.

We also visited the house of Bhagwat Singh (19 years). He and his brother Ram Chandra had just returned in the evening after the day's duty from the company and were to take tea, when the police entered and beat them with lathis and rifle butts. Their mother pleaded with the police not to beat them and said that they had just returned from their duty. But she was also beaten. She has swelling and injury in one of her legs. Bhagwat Singh was in a bad condition. He said he and his brother did not know for what reasons they were beaten. Only later on they came to know about the day's developments in the Colony.

A ten year old girl Mino told us that she was dragged by her hair and beaten. A 12 year old boy Rajkumar who was on his way to collect fodder for his cattle was also not spared. He received lathi blows on his back and hit with butend of the rifle. An old shopkeeper who just enquired why people were beaten also received on or two blows.

We enquired about the genesis of the trouble and came to know that the whole thing arose out of a quarrel between a young couple. Muzamil's wife did not want to live with her husband. The police had intervened on behalf of the young wife and wanted to take her away.



The husband and his people were not willing to leave unless there was a settlement with her parents and the ornaments which were given to the girl were returned. I need not go into the details narrated to us regarding the quarrel. Sufficient to say that some people objected to the girl being taken away by the police without making the settlement then a bigger police party and the girl's father came and tried to take away the girl from the place of their community pradhan with whom the police had left the girl pending a settlement. We were also told that this time there were some outsiders also along with the police party. We were also told that when some people objected to the girl being taken away without a settlement there were some arguments among those gathered there and the police suddenly lathi charged the people. Meanwhile a batch of PAC men had reached the spot. Together with them the police made a wanton attack on the local people. Houses were raided, people were dragged out and beaten up. The CPI Office was one of the targets of attack.

We had visited the house of Muzamil and found his old mother two sisters, one a teen aged girl, lying on coats. Only the old woman was able to talk. She said they were badly beaten after they were taken to the police station at about 5.30 p.m. They were let out from the police station at about 9.30 in the night. Both his sisters were lying semiconscious. They had marks of beating on their bodies, hands and legs. The elder girl was married and pregnant. They required immediate medical attention.

From what we have seen and heard we come to the irresistible conclusion that an unfortunate family quarrel which could have been settled tactfully and amicably was handled by the police in such way that could be used as a pretext by the police for mounting a wanton



attack on the people, the local CPI workers and for ransacking the party office and arresting a number of people including local CPI leaders.

Shahidnagar is a colony settled by poor people like workers, hawkers, petty shopkeepers etc. Some eight years ago poor workers and other homeless people started constructing their huts on lands which were lying vacant outside Ghaziabad town. Gradually a colony began to come into existence there which was later known as Shahidnagar. Today there are 3000 families living in Shahidnagar in its eight blocks. Ever since the poor people settled there, there were several attempts to evict them and demolish the entire settlement either by the landlord Ramprakash Gupta who claims himself to be the owner of the land or through his agents and sometimes with the help of some officials. Each time the residents had foiled these attempts under the leadership of the CPI local unit. Ghaziabad Municipal council has now included Shahidnagar within the municipal limits and has provided a few civic amenities like tube wells. Hence the CPI workers in Shahidnagar had incurred the wrath of the landlord and his henchmen. They have also incurred the wrath of some black marketeers and their goondas. The family quarrel mentioned above and the intervention of the police in the quarrel gave them a good opportunity to wreak vengeance on the CPI workers and the local residents. The presence of outside elements during the trouble strengthens this conclusion.

Altogether 20 people have been taken into custody out of which eighteen are in the police lock-up and two are in the hospital undergoing treatment. The arrested people include all the leading CPI workers besides branch secretary Rahmat Ali. The two persons admitted in the hospital are Abdul Halim secretary of the District Youth Federation



and Nanva Maistry a carpenter. Nanwa was the same carpenter who was working in the party at the time of the police attack. The condition of both is serious. Besides a number of people including women and children had been beaten and injured and they were left in the Colony without any medical attention.

I regret to point out that the police had behaved in an atrocious manner and the violent and indiscriminate attack on the people including women and children in their houses was totally unwarranted and the ransacking of the party office and arrest of party workers were an act of political vindictiveness.

I request you to personally look into this incident with the seriousness it deserves and take prompt action in suspending the police officers who were responsible for this outrage and in paying compensation to those who were injured and to order a judicial enquiry into the whole episode so that full justice is done to the victims of this outrage and guilty are awarded proper punishment.

I hop that you will take the necessary action in this case and see that such atrocities are not repeated in future.

# शहीद नगर के निवासियों पर पुलिस का बर्बर हमला

## महिलाओं समेत अनेक घायल

नयी दिल्ली, ३ मार्च (जस) : दिल्ली-उत्तर प्रदेश सीमा पर गाजियाबाद के निकट गरीब मजदूरों की बस्ती शहीद नगर में गत रातवार एक मार्च की शाम को पुलिस द्वारा बस्ती के निवासियों पर किये गये वृहत्संख्यक हमले और बर्बर लाठीचार्ज में लगभग चालीस से अधिक लोग घायल हो गये हैं जिनमें लगभग बीस महिलाएँ हैं। घायलों में दो की हालत गंभीर है जिन्हें इलाज के लिए एम. एम. एच. अस्पताल, गाजियाबाद में भर्ती कराया गया है।

दिल्ली की सीमा से लगी हुई करीब १५ हजार की आबादी वाली इस बस्ती में लगभग आधे घंटे तक यू.पी. पुलिस द्वारा की गयी इस आतंकपूर्ण कार्रवाई और बर्बर लाठीचार्ज का मुख्य निशाना भारतीय कम्युनिस्ट पार्टी के शहीद नगर स्थित स्थानीय कार्यालय, कम्युनिस्ट कार्यकर्ताओं और महिलाओं को बनाया गया।

आज सुबह जनयुग संवाददाता ने बस्ती का दौरा करने पर पाया कि लोगों में अभी भी पुलिस का आतंक बना हुआ है। लोग डरे-डरे से घरों से बाहर आ-जा रहे हैं। कई लोग पुलिस के भय से अपने घरों से बाहर हैं।

कम्युनिस्ट पार्टी शहीद नगर ब्रंच के कार्यालय में घुसकर पुलिस द्वारा की गयी लूटपाट और कार्यकर्ताओं पर

लाठीचार्ज के निशान तथा मृत के धब्बे अब भी वहाँ मौजूद हैं। पुलिस ने पार्टी कार्यकर्ताओं और अन्य बस्ती के निवासियों पर न केवल लाठियों की वर्षा की बल्कि कार्यालय पर लंगे लात भेड़ें को फाड़ दिया, सभी कागजात तथा रिकार्ड फाड़-फूड़ कर इधर-उधर फेंक दिये व कुछ को जला दिया। उस समय वहाँ काम कर रहे एक बड़े मजदूर ६० वर्षीय ननुका मिस्त्री को भी पुलिस ने नहीं छोड़ा। बताते हैं, उस पर लगभग ३० लाठियों पड़ी हैं तथा इस समय वह गाजियाबाद अस्पताल में भर्ती है।

जिला यूथ फेडरेशन के संयोजक ३० वर्षीय अब्दुल हलीम को भी शरीर में जगह-जगह चोटें आयी हैं तथा वह चल फिर सकने के कारिबल नहीं है। फिर भी पुलिस ने उन्हें गाजियाबाद अस्पताल में हथकड़ी लगा कर बिस्तर पर डाला हुआ है। पार्टी ब्रंच के सचिव रहमत अली खां को बुरी तरह पीटते हुए घसीट कर पुलिस की गाड़ी में ले जाया गया।

इस वृहत्संख्यक हमले के दौरान पुलिस ने महिलाओं, बच्चों और बूढ़ों तक को नहीं छोड़ा। एक ३५ वर्षीय गर्भवती महिला को भी पुलिस ने बंदूक के कुन्दा से मारा तथा उसके पति को गिरफ्तार करके ले गयी। पुलिस की मार से घायल पड़ी महिलाएँ रफीकन (४५ वर्ष), जायदा (१८ वर्ष), बशीरन (६५ वर्ष), जयबन (२५ वर्ष), हकीमन (३० वर्ष) तथा कलमुमन अभी भी चारपाई पर पड़ी हैं तथा घटना को दो दिन बीत जाने के बाद भी अभी तक इन्हें प्राथमिक चिकित्सा तक नहीं मिली है।

बताते हैं, यह सारी घटना एक घरेलू झगड़े को लेकर शुरू हुई जिसमें अगर पुलिस चाहती तो बिना मारपीट के शांतिपूर्ण ढंग से हल कर सकती थी। घटना के अनुसार गाजियाबाद की एक लड़की खातून

(१) की शादी लगभग ४ साल पूर्व शहीद नगर निवासी मुजम्मिल (२२) हुई थी। उसे ८-९ माह का एक बच्चा भी है। लेकिन कुछ दिनों से लड़की अपनी ससुराल में नहीं रहना चाहती थी तथा उसके मां-बाप उसे वापस ले जाना चाहते थे। पर खातून के पति का कहना था कि उसने जो जेवरगत आदि बनवा कर उसे दे रखे हैं वह वापस करके वह अपने घर जा सकती है।

बताते हैं कि गत २९ फरवरी को

एक पुलिस पार्टी आयी और खातून को समाज के प्रधान चौधरी कालू के आश्रम में यह कह कर छोड़ गयी कि उसके मां-बाप आकर उसे लिया जायेंगे। उस समय फैसला यह हुआ कि दोनों परिवारों के लोग मिल-बैठकर फैसला कर लेंगे।

लेकिन बताते हैं कि अगले दिन लड़की का पिता बजाये गहने आदि लेकर आने के दोपहर में साथ में पुलिस पार्टी लेकर आया। उस समय पुलिस ने जब लड़की को ले जाना चाहा तो इलाके के कुछ अन्य लोग भी एकत्रित हो गये और उन्होंने आपत्ति की। इस बीच पुलिस ने इसकी सूचना ऊपर भेज दी तथा और फोर्स मंगा ली।

शाम लगभग साढ़े ५ बजे तीन टुकों में दो-दोई सौ पुलिस बस्ती में आ गयी और घर-घर में जाकर (शेष अंतिम पृष्ठ पर)



# पुलिस का हमला

(प्रथम पृष्ठ का अंश)

लोगों से यह पूछना शुरू कर दिया कि रहमत अली कहाँ है। बताते हैं कि कुछ सादी बर्दी में भी लोग पुलिस के साथ आये। उस समय का रहमत अली खां पार्टी कार्यालय में अपने ८-९ कार्यकर्ताओं के साथ बैठे थे और स्थिति पर विचार-विमर्श कर रहे थे तथा इस संबंध में उच्च अधिकारियों से मिलने के लिए एक प्रतिनिधिमंडल ले जाने की सोच रहे थे। तभी अचानक पुलिस ने पार्टी कार्यालय में घुस कर डड बरसाने शुरू कर दिये।

इसके साथ ही पुलिस ने अन्य घरों में भी घुस कर महिलाओं, बच्चों और बूढ़ों को जो भी मिला मारना-पीटना शुरू कर दिया। घटना से सम्बद्ध मुख्य युवक मुजम्मिल के घर पर भी पुलिस ने हमला किया तथा उसे उसके पिता तुल्लन मास्टर और छोटे भाई दाउद को मारते-पीटते हुए पकड़ कर ले गयी। मुजम्मिल की दो बहनों जायदा (१८) और जयबन (२५) तथा उसकी मां बशीरन की लाठियों और बंदूक के कुंडों से पीटाई की गयी बताते हैं। तीनों अभी तक चारपाई से उठने लायक नहीं है तथा जायदा आज भी पीड़ा संकराह रही थी। घर में कोई पुरुष नहीं बचा है जो इन महिलाओं को देखभाल कर सके।

खुर्जा से आये एक १६ वर्षीय बालक सिन्दू और उसकी मां रफीकन (४५) को भी गहरी चोटें आयी हैं। ये दोनों यहाँ अपने किसी संबंधी से मिलने आये हुए थे। सिन्दू के सिर व बाजू में पांट्टियां बंधी हैं। बयालिस वार्गीय छिद्दन ने बताया कि वह नमाज पढ़ने जा रहे थे, पुलिस उन्हें मस्जिद से बाहर खींच लाई और पीटाई की। ठाकुर चाय वाले की सारी काकरी तोड़ दी गयीं। एक अन्य बंगाली चाय वाले को पुलिस पकड़ कर ले गयी तथा उसका दूध व अन्य सामान बिखेर दिया गया।

पार्टी कार्यकर्ताओं ने बताया कि पुलिस उन पर हमला करने का कबल एक बहाना खोज रही थी। क्योंकि यह इलाका कम्युनिस्ट पार्टी का गढ़ है तथा यहाँ के अष्ट पुलिस अधिकारियों और कर्मचारियों के खिलाफ वह जनता को संगठित कर अक्सर आवाज बुलंद करती रही है। लगभग ८-९ साल पुरानी इस बस्ती पहले न तो पानी का प्रबंध था न बिजली का। कम्युनिस्ट पार्टी के नेतृत्व में अनेक आंदोलन हुए। १९७८ में १२८ कार्यकर्ताओं ने गिरफ्तारो दी तो बिजली के अस्थाई खंभे लगें और दो दिन बिजली भी जली लेकिन उसके बाद से बिजली गायब है। पानी के दो नल भी लगे तथा पांच साल बाद जाकर दो राशन की दुकान भी खुली। लेकिन इलाके के कुछ भूस्वामियों को जो बस्ती की जमीन का अपने आपको मालिक बताते हैं, ये सब देखा नहीं गया तथा ये लोग स्थानीय पुलिस और किराये के गुंडों को लेकर लोगों को उजाड़ने के लिए समय-समय पर हमला करवाते रहे हैं। इनमें रामप्रकाश गुप्ता नामक एक धन्नासेठ भी अपने आपको शहीद नगर की जमीन का मालिक बताता है। लेकिन बस्ती के निवासियों की एकजुटता और संघर्ष के कारण वह अपने प्रयासों में सफल नहीं हो सका। परसों की घटना ने पुलिस तथा भूस्वामियों के गुंडों को एक सुनहरा मौका दे दिया और पुलिस निहत्थे नागरिकों पर टूट पड़ी।

भारतीय कम्युनिस्ट पार्टी के संसद सदस्य पी. के. कोडियन और कालीशंकर शुक्ला ने शहीद नगर का दौरा करने के बाद कम्युनिस्ट पार्टी के कार्यकर्ताओं और निहत्थे नागरिकों पर पुलिस द्वारा किये गये इस बर्बर जुल्म की सख्त निंदा की है तथा सारे मामले की न्यायिक जांच कराने की मांग की है। उन्होंने आज यहाँ एक प्रेस वक्तव्य जारी कर उन सभी दोषी पुलिस अधिकारियों को दंडित करने की मांग की है जो घटना के लिए जिम्मेदार हैं तथा गिरफ्तार किये गये सभी २० लोगों को तत्काल रिहा करने, घायलों व जिनका सामान बर्बाद हुआ है उन्हें राहत देने की भी मांग की है।

Sh. P.K. Kodiyan, M.P. and Sh. Kalisankar Sukla both the leaders of the communist party of India issued the following statement.

We had visited Shahid Nagar in Ghaziabad to enquire into allegation of Police atrocities against workers and poor people of the area and arrest and beatings of C.P.I. workers and ransacking of Shahid Nagar Party Office.

We had found the party office ransacked the party flag hauled down and the furniture and records thrown every where, and the burnt remains of some papers. We also saw the wooden pieces on which a Carpenter who working and blood stains on the floor and the wood pieces. The police on the evening of 1st March had suddenly attacked the party office, beaten up the party workers including party branch secretary Rehmat Ali and dragged them to the Police Van.

A large number of people including old women and children had been beaten by the police. We found some houses which were forcibly broken by the police and the belongings thrown all over the house. From one tailor master's house it was complained by the women that a suit case and jercy were taken away by the Police. They did not even spare the local mosque. Some people were dragged out of the mosque, premises. We found sixty year old woman Rafikan lying on a coat wreathing in pain. She had been beaten with lathi severely that marks of lathi blows were on her both hands left beg. Her both hands were injured. Her 13 year old son Sundu was lying Semi Conscious all over his body there were marks of lathi blows. His elder brother also received lathi blows. The police did not spare even children. A ten years old girl Mino told us she was caught by her hair and beaten. Twelve year old Rajkumar was going out for bringing fodder for his cattle. He was caught and beaten and was given **blows on his** back with buttend of the rifle.

The police had **ran** amuck, entered houses, beat up people indiscriminately. Ninteen year old Bhagwat Singh and his brother Ram Chandra had just ~~xxxxxxx~~ returned after their duty at 5.P.M.

Just then Police entered their house, started beating them. Their mother pleaded with the police. She was also given blows. Bhagwat Singh has a number of injuries on his hands and legs. He was unable to move from his bed. Ram Chandra was also injured. Their mother has an injury on her leg. Ramchandra said they did not even know for what reason they were beaten. Ramsaran Das (60 years) the owner of a small grocery shop in B. Block. told us that seeing the police beating the people, he just enquired why they were beaten, then he was also beaten by the Police.

From our enquiry we understand that the whole trouble started with a family quarrel between a young husband and his wife. That ~~Muslim's~~ <sup>Musamil's</sup> wife did not want to live with her husband. A Police party came to take away on 29th Morning. We were told that her husband's people demanded the ornaments which they had given to be returned before taking her away. The young woman was then taken by the police and left under the care of their community Pradhan Choudhary Kalloo. The understanding was that her father should come and settle the matter and take away his daughter. We were also told that the father did come in the afternoon not with ornament with a police party led by a sub-inspector. When the father & Police tried to take away the girl without giving the ornament and settling the matter, some people objected. We were also told that the Police then without any warning lathi charged the people who had collected. Mean while the police had phoned for reinforcements. A batch of PAC men came on the spot and that started the large scale indiscriminate attack on the people. It was said that some outside elements had also come with the police. Com. Rehmat Ali and other people were just discussing the development and the representation to be made to the authorities. It was then that the attack on the party office took place.

We also visited the house of Musamil the husband of the girl, who was involved in the dispute. Mozamil his 65 years old Wasiran, his two sisters Jaimunisa (25 years) Jayada (18 years) were taken into custody in the evening and were released from Police Station at about 9.30 in the night, except Muzamil



All of them including the old woman were lying on coats in their house. Only the old woman could talk to us. She said they were all beaten. Both the younger girls were in a Semi Conscious condition. They had several marks of beating all over their bodies. The younger one had a wound below her left eye. Both the girl required immediate medical attention. The elder girl married and pregnant.

From what we have seen and what we have heard we come to the conclusion that a family quarrel which could have been settled amicably was utilised by the police to mount on wholesale attack on the people of the area and to attack and ransack the C.P.I. Office and arrest, beat and lock up the party workers and involve them in a number of criminal cases. Altogether 20 people have been arrested. Eighteen persons are in police lock up and two are admitted in Ghaziabad hospital. Of the arrested people nine are party members. They include the branch secretary also. We have met the people in lock up. Many of them have injuries. We also met those who were admitted in Ghaziabad hospital. One is Abdul Halim, Convener of the District Unit of all India Youth Federation and other is sixty years old Nunwa Maistry a carpenter. Both of them are in a serious conditions.

Shahid Nagar is a colony inhabited by <sup>poor</sup> people and workers hawkers petty shopkeepers etc. Poor homeless people some eight years ago had occupied this land and constructed their huts and small houses. The land at the time was lying vacant and was claimed by One Ram Prakash Gupta rich landlord belonging. Since then several attempts were made to evict the people and demolish the colony. Every time the people had foiled these attempts under the leadership of the Shahid Nagar Unit of the C.P.I. As a result of the sustained education conducted by the people, Ghaziabad Municipality has now included Shahid Nagar in the Municipal Area and provided some facilities like setting up of tube well ~~xxxx~~ etc. This has angered the landlord and his henchmen. The unfortunate family gave irrate landlord and his hunchmen to wreak vengeance on the people of the colony and the party worker. who had led them in their struggles, and the police as elsewhere in the state were at the service of such rich people.



We strongly condemn the Police high handed and their wanton attack on the poor people and the ransacking and arrest of C.P.I. Workers and demand the release of arrested workers, pay compensation of those who were injured and punish the Police Officers and their men who were responsible for this totally unwarranted and high handed action, and order a judicial enquiry into the whole incident.

We had visited Shahid Nagar in Ghazipur  
to enquire into allegation of police atrocities  
against workers and poor people of the area and  
arrest and beatings of CPI workers and ransacking  
of Shahid Nagar party office.

We had found the party office ransacked,  
the party flag hauled down and the furniture  
and records thrown ~~to the~~ everywhere, and the best  
remains of some papers. We also saw the wooden  
pieces on which a Carpenter was working and  
blood stains on the floor and the wood pieces.  
The police on the evening of ~~29th February~~ <sup>1st March</sup>  
had suddenly attacked the party office, beaten  
up the party workers including party branch  
secretary Rahmat Ali and dragged them  
to the police van.

A large number of people including  
old women and children had been beaten  
by the police. We found some houses which  
were forcibly broken by the police and  
the belongings ~~was~~ thrown all over the  
house. From one tailor master's house it  
was complained by ~~the~~ the women that a  
suit case <sup>and press</sup> ~~was taken~~ were taken away  
by the police. They did not even spare the local  
mosque. Some people were dragged out to the  
mosque premises. We found sixty year old woman  
Rafikan ~~to~~ lying on a cot writhing  
in pain. She had been beaten with lathi  
severely that marks of lathi blows were  
on her both hands left leg. Her both hands



were injured. Her 18 year old son Sunder was lying semi-conscious. All over his body there were marks of lathi blows. His elder brother also received lathi blows. ~~The~~ The police did not spare even children. A ten year old girl Guro told us she was caught by her hair and beaten. Twelve year old Rajkumar was going ~~some~~ out for bringing fodder for his cattle. He was ~~going~~ <sup>beaten</sup> and ~~beaten~~ <sup>and was given blow on his</sup>. The police had seen amuck, entered houses, beat up people indiscriminately. Nineteen year old Bhagawat Singh and his brother Ramchandra had just returned after their duty at S.P.O. Just then police entered their house, started beating them.

Their mother pleaded with the police. She was also given blows. Bhagawat Singh <sup>was given</sup> a <sup>has</sup> number of injuries on his hands and legs. He was unable to move from his bed. Ram Chandra was also injured. Their mother has an injury on her leg. Ramchandra said they did not even know for what reason they were beaten. Ramsooran Das (60 years) was the owner of a small grocery shop in B. Block. ~~He~~ <sup>He</sup> told us that seeing the police beating the people, he just enquired, why they were beaten. # then he was also beaten by the police.

~~From what we have seen and what we had heard from the people, we have no hesitation to say that the police had behaved in a high handed manner and had beaten up people indiscriminately.~~

~~We visited the house~~ <sup>we understood that</sup>  
From our enquiry, the whole trouble started with a family quarrel between



a young husband and his wife. Musamil's wife  
 — did not want to live with her husband.

Police party came to take away on 29<sup>th</sup> morning.  
 We were told that her husband's people demanded  
 the ornament which they had given to be returned  
 before taking her away. The young woman was then  
 taken by the police and left to be under  
 the care of their Community Panchayat Chondhary  
 Kalloo. The understanding was that her father  
 should come and settle the matter and take  
 away his daughter. But the father We were  
 also told that the father did come in the  
 afternoon not with ornament with a police  
 party led by a sub. inspector. ~~She~~ and further  
 when the father and police tried to take  
 away the girl without giving the ornament  
 and settling the matter, some people objected.  
 We were also told that the police then without  
 any warning lathi charged the people who  
 had collected. Meanwhile the police had  
 phoned for reinforcements. A batch of P.A.  
 men came on the spot and then started  
 the large scale ~~attack~~ indiscriminate  
 attack on the people. ~~Some~~ It was said  
 that some outside elements had also come  
 with the police. Com. Rahmat Ali and  
 other people were just discussing the  
 developments and the representatives  
 to be made to the authorities. It was then  
 that the attack on the party office took  
 place.

We also visited the house of Musamil  
 the husband of the girl who was involved  
 in the dispute. Musamil, his 65 year



old Waswan, his two sisters, Fairmunia  
~~and~~ (25 yrs) Jayeda (18 yrs) were taken into  
 custody in the evening and were released  
 from ~~the~~ police station at about 9.30 ~~pm~~  
 in the night. Muzamil except Muzamil.

All the boxes including the old woman  
 were lying on coats in their house. Only  
 the old woman could talk to us. She said  
 they were all beaten. ~~Among the girls~~  
 Both the younger girls were in a semi-  
 conscious condition. They had several marks  
 of beating all over their bodies. The younger  
 one had a wound below her left eye. Both  
 the girls required immediate medical  
 attention. The elder girl was married and  
 pregnant.

From what we have seen and what  
 we have heard we come to the conclusion  
 that a family quarrel which could have  
 been settled amicably was utilised by  
 the police to mount an wholesale attack  
 on the people of the area, and to attack  
 and sack the CPI office and arrest  
~~and~~ beat and lock up the party workers  
 and involve them in a number of criminal  
 cases. Altogether 20 people have been  
 arrested. Eighteen persons are in police  
 lock up and two are admitted in Ghaziabad  
 hospital. Of the arrested people 9 were  
~~party members and the rest 11~~  
 are party members. They include the  
 branch secretary also. ~~They~~ ~~of~~ ~~them~~ ~~have~~



We have met the people in lock up. Many of them have injuries. We also met those who were admitted in Ghasiabad hospital. One is Abdul Halim Convener of the District unit of all India Youth Federation and other is Sixty years old Nanwa Maistry a Carpenter. Both of them are in a serious condition.

Shahidnagar is a Colony inhabited by poor people workers, hawkers petty shopkeepers etc. Poor ~~home~~ homeless people some eight years ago had occupied this land and constructed their huts and small houses. The land at the time was lying vacant and ~~subsequently~~ was claimed by one Ram-prakash Gupta a ~~low~~ rich landlord who belonged. Since then several attempts were made to evict the people and demolish the Colony. Every time the Communist party unite people had foiled these attempts under the leadership of the Shahidnagar unit of the CPI. As a result of the sustained agitation conducted by the people, Ghasiabad municipality has now included Shahidnagar in the Municipal area and provided some facilities like setting up of tube wells etc.

This has angered the landlord and his henchmen. The unfortunate family quarrel was utilised gave rise to a loss and his henchmen to wreak vengeance on the people of the Colony and the party workers.


