Most Respectfully sheweth:

1. That this writ application is for quashing the office order no.17 dated 8.7.1976 (contained in Annexure-3) by which the seniority of the petitioner has been fixed at serial no.20 and for restoring the seniority of the petitioner, as fixed by office order no.384 dated 18.6.75 (contained in Annexure-2) at serial no.15 by an appropriate writ

writ, order or direction in the circumstances set forth below.

- 2. That the following points are involved in the case:
  - (i) the seniority of the petitioner has been arbitrarily altered on his back without notice to him;

cadre of service in class III. At that time the petitioner was an intermediate.

- 4. That the petitioner was confirmed in service with effect from 1.12.70.
- 5. That the petitioner graduated on 26.5.197
- That it was the grievance of the employ 6. of the non-clerical cadre that they have a muchlo chance of promotion as compared to the employees the clerical cadre. Accordingly an agreement was reached into by the All India Reserve Bank Empl Association (Respondent no.6) and the managemen Respondent no.2 which provided that an employed the non-clerical cadre who has acquired a gradu degree may apt for a switch over to the clerica subject to the condition that(i)irrespective of his date of graduation it will bedeemed that he has graduated on 7.5.72 and (ii) for the purposes of seniority only 1/3rd of his service in the non-

cadre will be taken into account. It was also provided that those who become graduates after 7.5.72 may apply within one month of their graduation for the switch over.

The petitioner craves leave this Hon'ble Court to refer t copy of agreement at the tim of hearing of this applicati

- 7. That two months' time was allowed for application for switch over which was again extended by one month.
- attached at the foot of this application mentioned in Schedule A/and many others filed their application for switch over from non-clerical to the clerical cadre. The petitioner did not file any application. It may be mentioned that the respondents whose names have been mentioned in Schedule B attached the foot of this application are staff of cleric cadre from before.

- applications for those employees who had still not filled their applications by office order no.24 date 15.7.74 a copy of which is annexed hereto as

  Annexure-1 to this application. By Annexure-1 the period for filing applications was extended upto 31.7.74. It was further directed unilaterally that for the employees applying before 31.7.74 only the 1/3rd service upto 15.1.74 will be taken into according their seniority.
- petitioner filed his application for switch over from non-clerical cadre to the clerical cadre on 31.7.74

  11. That the actual dates of appointment, date of confirmation, and dates of transfer to the clerical cadre of some of the respondents are given in the schedule A attached at the foot of this application. The Schedule B attached at the foot of this application contains the names and details of those respondents.

- 12. That after the transfer of the petitioner his seniority was fixed at serial no.168 is accordant with office order no.384 dated 18.6.75, a copy of which is annexed hereto as Annexure-2 to this application.
- 13. That surprisingly without any informatic to the petitioner office order no.17 dated 8.7.197 was issued changing the seniority of the petition A copy of the order dated 8.7.1976 is annexed her as Annexure-3 to this application. By annexure-3 petitioner was made junior to the respondent no.7 to 56 and his seniority was fixed at serial no.20 It may be mentioned that in the meantime Maheshwa had died and Felix Cherobin, Jagdish Das, Sitaran Barnwal have resigned from service and therefore they are not made parties although they were also made seniors.

- (a) In the case of employees shore applications were received by the Bank up to 7th lugust

  1972, on the basis of 1/3rd service up to

  7th May 1972.
- (b) In the case of employees whose applications
  are received by the Bank after 7th August 1972,
  but upto 31st July 1974, on the basis of 1/3rd
  service up to 15th January

1974.

Accordingly, the non-clerical employees who had submitted their applications up to 7th August 1972, may advise the Bank on or before 31st July 1974, whether they are interested in switchover to the clerical cadre on the basis of (a) above.

- 2. The eligible employees who had applied for switchover to the clerical cadre after 7th August 1972 and are still interested in switch-over as also those who did not apply at all may submit fresh applications on the basis of (b) above so as to reach the undersigned on or before 31st July 1974.

We have to submit that although we were eligible
and willing for switchover to the clerical cadre when
settlement, inter alia, on combined seniority was arrived at between the All India Reserve Bank Employees¹
Associations for seniority-consequential deterrent
restrictive provisions for seniority-fixation proved
to the prosecriptive for us and under such consistent
psychological stories we were unable to take decision within
the stipulated period we were unable to take decision
within the stipulated period of two months.

Fortunately, however, at the request of our
All India Association yet another opportunity was off

opportunity was offered to the employees vide lucal Manager's office Order No.24 dated 15th July, 1974. The terms of the new switch over scheme, enshringer therein, were further discouraging tentamounting to punishment for not taking the decision at the first available opportunity. This would be evident from the stipulation that the employees who were still working in the Cash Department as sufficiently junious were deemed to be seniors under the new arrangement simily because they had opted for switchover earlier, Despite these distscantives we exercised the required option so that we might not lose the opportunity for all time to come.

Notwithstanding the above, we have to state that consequent upon the exercise of option by we we were due to be transferred under clause 7(a) which is the relevant clause for invoking the option under the aforesaid agreement and in our cases this clause was invoked prior to certain junior employees who have now

who have now been termed seniors ignoring the fact that they, part from being juniors, were transferred also subsequently as explained here above. This is the latic crus of our grievance and we hold that since we ware already seniors and were actually transferred limit, we continued to be seniors and as such we have legitimate preferential claim on seniority as against our juniors.

We feel that justice has been denied to us as would appear from the following:-

(1) Although applications for the transfer from the non-clerical to the clerical cadre were invited twice i.e. firstly in pursuance of the settlement dated 15th 7th May, 1972 and secondly in terms of office order dated 15th July, 1974 the applications received from our juniors were given effect to only after 15th July, 1974 and therefore seniority could be determined as from the date of actual transfer. Seniority determined

determined on the basis of the date of application is, thus, irregular and illegal.

- were actually transferred subsequent to our transferred having been effected, have been termed seniors on the plea of their application having been received earlier. Since they, having acquired the right to be transferred first, on the strength of their applications of prior dates, were actually transferred afterwards, they continue to be our juniors in the general side also. As such Bank's as action in accepting them as having superseded their seniors despite the fact of actual transfers subsequently is irregular and illegal.
- (iii) Clause 7(a) of the settlements dated the 7th May, 1972 continues to be in operation notwith—standing the provisions contained in the office order dated 15th July, 1974 since the said office order was issued in pursuence of the aforesaid settlement and had

and had no independent validity. And after actual transfers to the general side the seniority has to be determined under clause 7(a) in terms of which we continue to
be seniors as against our juniors who cannot suppersade
us after having been transferred subsequently to a clare
(thereby being less experienced as compared to us )
for which over to which employees are required to forego
substantial seniority acquired as a Coin/Note comminers.

that when certain contradictory stipulations have created contradistinctive positions at the implementation stage we cannot be punished by pushing back the factual position which evidently supports our legitimate claim over the seniority wise vis-a-vis our juniors right from the dates of our appointments. In such cases the benefit of contradictions has to go to the actually senior employees which we are, we may kindly be permitted to add further that if just by not exercising option within the stipu-

which virtually cannot be treated more than an exercise on paper in the absence of actual transfers having been effected as on the date of second available opportunity under similar logic we cannot be restrained from acquiring legitimate seniority consequent upon actual transfers on prior date.

In view of the foregoing the balance of justice is obviously on our side and we stake our claim through this representation and seek justice from your kind self.

extension of time to exercise option for switchover to

the clerical cadre. The extention of time was granted

subject to the following terms and conditions in regard

to fixation of the seniority in the clerical cadre:-

- a) In the case of employees whose applications were received by the Bank up to 7th August 1972, on the basis of 1/3rd service up to 7th May 1972.
- In the case of employees whose application

  were received by the Bank after 7th August

  1972, but up to 31st July 1974, on the basis

  of 1/3rd service up to 15th January 1974.

Thus non-clerical employees eligible as on 7th May 1972 who would have otherwise lost the right to exerciase option for switchover, were given on opportunity to switchover by extending the period for exercising

option. Their seniority in the combined seniority list was subject to the terms and conditions mentioned in the office order no. 24 dated 15th July 1974.

- scheme dated 13th May 1972 regarding maintenance of inter se position of the non-clerical employees in the concerned seniority list as it stood immediately before 7th May 1972 are not applicable in the case of employees exercising option in terms of office Order no.

  24 dated 15th July 1974. Inter se peniority is maintained only as between the employees in each batch of Shri Bharat Kumar who exercised option in terms of the said office order no. 24 has been correctly fixed according to the principles stated above.
- 4. As regards the specific points raised by him in his representation, Shri Bharat Kumar is advised as under:
- 1) As regards his contention that his seniority had been correctly fixed at 51.no.168 in terms of office

order no.384 dated 18th June 1975, Shri Bharat Kumar is advised that on his exercising option to switchover, while fixing his seniority in the combined seniority list, his inter se position was erroneously maintained with reference to the senioritynposition of the optees who had applied for y switchover within the time specified as under the scheme annexed to Administration Circular no. 9 dated 13th May 1972. His seniority position was, therefore, not then correctly fixed and had to be rectified. The error was rectified and the revised seniority position of Shri Bharat Kumar was notified by this office vide office order no. 17 dated 8th July 1976. His contention that his seniority had been revised arbitrarily by placing him at Sl. no.221 in the seniority list is not correct.

transfer were invited twice, all the applications were given effect to only after 15th July 1974 is not relevant for the purpose of fixation of seniority in the combined seniority list.

- (iii) His submission that the seniority should be fixed on the basis of the date of actual transfer and not on the basis of date of application is control, to the provisions of the combined seniority scheme.
- clerical staff who joined the Rank's service after him and had been actually transferred subsequent to him, become senior to him merely because they had applied earlier, Shri Bharat Kumar is advised that inter-se position is maintained only as between employees of each batch of optees. He is advised that the employees listed by him in Annexures II and III who have become senior to him in the combined list an had exercised option before 7th August, 1972. The date of actual transfer to clerical duties is not relevant for fixation of seniority.
- (v) His contention that clause 3 of the settlement dated 7th May 1972 clearly provides that "in no case a junior will be made a senior and vice versa" is not correct as inter-se seniority is maintained only as between the employees extraining option in each patch. Clause 4(a)

of the scheme is not relevant as he had emercised option in terms of office order no.24, clause 7(a) is not relevant as it deals with actual transfer to clerical duties.

5. In the result, the request of Shri
Bharat Kumar for restoring him seniority position as
contained in Annexure II cannot be allowed and is
rejected.
