

The brief facts of the complaint are that the complainant is a employee of Ma/Fashion Express. In is General Manager and Manager of the company to be gave 20% bonus/ gift of theemployees of the company but they did not gave the same and misuse the money regarding which the complaint was made on 9-11-2005 before Labour Officer who fixed on 14-11-2005 as a date for personal hearing. By this complaint, the General Manager and Manager of the company for taking personal grudge against the complainant. On 10-11-2005 accused no.1 called employees in the meeting and started abuses them. He also threatened the complainant and other comployees to put to death. The accused also harassed them sextually. Hence, the present complaint.

Guinanna In order to prove his case, complainant examined herself as PW-1, Veena Devi as PW-2, Somwati as PW-3 and Ravinder Kumar as PW-4 and also placed on court file some documents. Evidence of complainant was closed on 13-2-2006 by ld. counsel for complainant.
